Public discussion -

Planning application for new pavilion in Park. Residents had process concerns- unhappy that comments made in the Thorney Post are at odds with the submission of the application being submitted.

Concerns on the planning application - parking is not adequate and no traffic management to park on Tavistock Close or Woburn Drive. The position of the building obstructs view of park. Potential for anti-social behaviour

On- going issues with car parking and owners running their cars pushing pollution onto the adjacent properties.

Concerns that area dedicated for biodiversity, is the area that could be used for additional parking. A resident asked if the Football facility could be located to a different location- the park is a recreational facility for any sport.

Cllr Ormston suggested a Facebook post to address the concerns.

Cllr Allen suggested the Parish Council could withdraw the application and review the plans and engage further with residents.

A request has been made to carry out litter picking in the village for the Gold DofE Award. This would be for an hour a week. Thorney Parish Council would then be asked to sign the D of E certification. Mr Parker doubted we could authorise this under the Parish Council due to insurance and H&S and both of these would be checked with Thorney Parish Council insurer.

Concerns about the lorries using Station Road, causing vibrations through the houses. There is a large dip outside Kingsline Close, two drains outside 43 Station Road and Sherwood House need attention. Speedwatch has not yet recorded any lorries speeding. Cllr Allen and Cllr Ormston to take these concerns forward. Resident highlighted that pictures and emails have previously sent to PCC, but no response received back.

Whittlesey Road – update needed from Highways Director at PCC concerning alternative route for quarry lorries.

- 2. Good Neighbours-Rural Peterborough (GNRP) Mrs Long received a response from Good Neighbours who advised 'I am now in a position to advise that the reduction of the annual fee, for the coming financial year 25/26, has been agreed, this will be a 50% reduction, for this one year at a rate of £1582.50.' It as proposed by Mr Williams, seconded by Mr Winch and agreed (with one abstention) to renew for another year. It was agreed to request more support for recruitment. We would need more specific details of residents of Thorney who benefit in the next renewal request. Mrs Halfhide raised her concerns regarding the fee to the coordinator. It was agreed that the Chairman would write to Good Neighbours to inquire what the fees covers and benefits to Thorney residents- how many use the service, number of local volunteers and hours they volunteer. There are only two paid employees. Request support in recruiting more volunteers.
- 3. Bank account signatories updated to include the finance committee members.
- 4. Bank debit card we have always paid either by cheque or bank transfer. However, with internet purchase's a debit card is often the only way to proceed and examples of recent purchases by this method given. It was proposed and agreed to have a Parish Council debit card with the same financial controls in place as exist at present for cheque and bacs payments.
 - 5. Interment charges not to be made for the interment Mr Stimson

6. Christmas Hampers- were distributed to the school by Mr Shearman. Receipts totalling £62.57 - this is much less than we had budgeted for due to generosity of Sainsbury's. Each Christmas hamper contained produce worth approximately £27.00.
